Superintendent of Schools Report :

Updates: Health and Safety- The Superintendent shared that the staff has created a Halloween celebration that they all feel comfortable with and it will be done differently but will allow students to participate in a celebration. She shared that the parade will be livestreamed and the kitchen will be making treats. We are also doing activities and games with the students.

Updates: Assessment- NWEA- Testing is going on and should finish soon. The NWEA is now the state assessment so it does look a bit different as far as reports and all. We also have to follow the state timelines for the test.

Updates: COVID and masking – The DOE expects schools to follow the standard operating procedure for cases. We have had some issues locally with Covid cases and because we are universally masked, we have not had to quarantine students from AES.
