Superintendent of Schools Report:

State Funding – Preliminary- Supt. Pratt reported that the state funding has gone from \$285,211.16 to \$358,611.47 according to the newest printout from DOE.

School Bus Approval- DOE- Supt. Pratt shared that the district has been approved for a 35 passenger bus reimbursed from the state funding. This will be in the budget as the district needs to purchase this and will get reimbursed over the next 4 years.

Principal's Report

Winter Term NWEA- Supt. Pratt gave the results of the mid-year NWEA assessment. 47% of the students exceeded expected (normed) growth in Mathematics since the Sept. assessment. 47% of the students exceeded expected (normed) growth in Reading since the Sept. assessment. 58% of the students exceeded expected growth in Language Arts (Writing and Grammar) since the Sept. assessment. This growth shows just how important it has been to keep students experiencing in-person instruction.
